PACKAGING UPGRADES

We will also take the opportunity of the brand harmonization to implement a few packaging enhancements:

⬡ **K-TIF, Ther-Biotic® for Infants**

We are adding a scoop for more accurate dosing! As such, we will increase the cobalt blue glass bottle size to 150cc (from 120cc) to accommodate.

⬡ **K-TF6, Ther-Biotic® Factor 6**

The fit is a little snug for this formulation—meaning it takes a little effort to get all the capsules in and out! So, here too, we are increasing the cobalt blue glass bottle size to 150cc (from 120cc) for streamlined dose dispensing.

⬡ **V776, Saccharomyces Boulardii**

As a component of the transfer to our brand new, purpose-built manufacturing facility, we are optimizing processes. One of these steps involves coordination of quality assurance and final packaging. We have found the *S. boulardii* in our ABx packaging (K-ABX) to be exceptionally robust and are therefore implementing the same approach with our stand alone *S. boulardii* product. From December forward both products will be packaged in our white plastic bottles.

⬡ **Private Label Packaging**

With our new facility, comes new technology. Beginning in Q4 2017, all private label products will be packaged using higher quality, pressure sensitive labeling: shiny and new!

CALIFORNIA'S PROPOSITION 65

Familiar to California residents, the 1986 proposition requires that manufacturers of any product, including supplements, sold into that state declare the potential for exposure to unsafe “contaminants” such as heavy metals. California’s limitations are far stricter than that of the globally recognized U.S. Pharmacopeia (USP). As such, we will take the opportunity of our brand unification to proactively comply with the most current regulations. In order to comply with Prop 65, products containing listed chemicals above OEHHHA’s threshold levels will display the appropriate warning statements.
