Background

Omega-3 fatty acids are often called "good fats" due to the numerous roles they play in supporting health throughout life. Among its many functions, adequate levels of EPA & DHA have been shown to support:

- Healthy lipid metabolism and cardiovascular function^{†1,2}
- Health central nervous system function $^{\scriptscriptstyle 3}$ and mood $^{\scriptscriptstyle \dagger 4}$
- Healthy inflammation modulation^{†5}
- Health metabolic function $^{\mbox{\tiny T6}}$
- Healthy pregnancy^{†7}

Unfortunately, it is common for Omega-3s to be deficient in the standard American diet, and the ratios of omega-3 fatty acids to omega-6 fatty acids are often suboptimal.¹⁸ The World Health Organization (WHO),⁹ American Heart Association (AHA),¹⁰ Institute of Medicine (IOM),¹¹ recommend consuming omega-3 fatty acids at levels between 500 mg to 1600 mg EPA and DHA daily to support general health, depending on age.
